## Licentiate in Safeguarding Application Procedure and Required Documentation

### 1. Application

**Step 1:** Please, fill out the IADC Application Form and send both the form and required documents (see below) in one email to [iadc-cand@unigre.it](mailto:iadc-cand@unigre.it) during the application period.

Please note that

- The Selection Committee will assess the documentation as a part of the evaluation process.
- Applications arriving after the deadline of December 20 will be rejected

### 2. Selection

**Step 2:** Once the application submission is complete and if it fulfills the requirements, you will be contacted to participate in an online personal interview with the IADC Selection team. The interview will take place between 15 February and 15 March 2024.

The exact date will be indicated at a later stage.

### 3. Communication of results

**Step 3:** After an overall evaluation of the documentation and the interview, you will receive notification of acceptance or refusal according to the criteria of acceptance indicated on the IADC webpage by the end of April 2024.

### Attached you will find the following documentation to be submitted:

- Application Form
- Confirmation letter form to be fulfilled and signed by your bishop/superior/director of work or by at least one former employer

The application must also include

- Curriculum Vitae (CV)
- Copy of your international passport
- Copy of the qualifications and grades obtained during previous university studies

- The candidate is not subject to any criminal or ecclesiastical sanctions
- The candidate is not the subject of any accusations or charges of abusive behavior, either now or in the past.

In the event of the positive issue of a confirmation of a candidate's suitability, we urge you to take these criteria into account. In order to facilitate the issuance of a letter of confirmation, we allow ourselves to provide a confirmation form, for you to be filled out and signed, attached to this cover letter.

The filled form has to be attached to the candidate's application form, to be submitted by 20<sup>th</sup> December 2023.
